SALE/FIELD SERVICE POLICY – ONLINE SALES

The National Swine Registry (NSR) offers Sale/Field Service as an option for those that wish to utilize NSR field representatives when hosting online pig sales. NSR field staff representatives will serve in a sale day consulting capacity for online sales. The following policy details the guidelines for requesting a field representative as a contact for online sales:

1. Sale Service Fee:

- A. A \$300 fee will be charged per sale to secure the services of a NSR field representative when hosting an online sale.
- B. This fee will be reduced to \$200 if the member records 100 litters or more on an annual basis.

2. Online Sale Services Provided:

- A. Upon securing sale service for online sales, the sale host will coordinate with the designated NSR field representative to agree on a time to view animals being consigned to the online sale.
- B. NSR field representatives agree to be listed as a sale day contact for the online sale and will field questions and inquiries on animals consigned to the online sale.

3. Field Representative Assignments:

- A. NSR field representatives will be assigned based on date of sale, location, and availability.
- B. NSR field representatives will not be available for online sale service during the week of or week prior to a NSR National Show & Sale.

SALE/FIELD SERVICE POLICY – LIVE SALES

The National Swine Registry (NSR) offers Sale/Field Service as an option for those that wish to utilize NSR field staff representatives when hosting live pig sales. NSR field staff representatives traditionally serve in a sale day consulting capacity for live sales and provide auction ring service. The following policy details the guidelines for requesting a field representative to attend a live sale:

1. Advertising:

- A. The sale host agrees to purchase a minimum of one full-page advertisement in the *SEEDSTOCK EDGE* magazine.
- B. The sale advertisement must run in the magazine issue immediately preceding the sale. Exceptions will be made for sales within ten days of the scheduled magazine delivery date, in which the sale host may choose to advertise in the previous month's issue.

2. Sale Service Fee:

- A. A \$300 fee will be charged per sale to have a field representative in attendance at the sale.
- B. This fee will be reduced to \$200 if the member records 100 litters or more on an annual basis.
- C. A second field representative can be hired, if available, for an additional \$300/\$200 plus expenses.

3. Field Representative Assignments:

- A. Field representatives will be assigned based on date of sale, location, and availability.
- B. Field representatives will not be available for live sales during the week of or week prior to a NSR National Show & Sale.
