GENERAL TERMS OF LEASE

1. Lease is valid for the following dates:

 - b. End Date: _____ animal will be transferred back to the Lessor on this end date or when NSR is notified by the Lessor and at the Lessor expense.

2. Lessee will feed and care for the animal for the duration of lease.
3. Lessee will be responsible for feed and show expense.
4. Lessee will not alter the ear notches of animal.
5. Lessee will not breed this animal or collect DNA for cloning without written consent from the Lessor.
6. Lessee will insure the animal for the duration and amount of the lease.
7. Lessor may, at any time, break this lease and recover the animal if the Lessor feels the animal is not properly cared for, mis-managed, or insurance is in default.
8. If lease is broken for any reasons listed in the above terms, the Lessee will have 10 days to return the animal to the Lessor and transfer of registration papers will occur prior to the listed end date.
9. If animal is sold through NSR open show and sale, NSR must be notified by the Lessee that the gilt is a leased gilt and that proceeds should be sent to Lessor.
