RE: GENERAL SHOW INFORMATION, HEALTH REGULATIONS

You are receiving this letter as confirmation of your NSR Extravaganza entries. Please adhere to the following reminders regarding general show information, arrival at the fairgrounds, penning and health regulations.

PLEASE ADHERE TO THE FOLLOWING:

BEFORE LEAVING FOR THE EVENT, PLEASE REMEMBER:

1. **ALL animals entering the Indiana State Fairgrounds MUST be listed on an official interstate health certificate of veterinary inspection (CVI) issued by a licensed, accredited veterinarian.** Loads containing swine that do not meet all NSR Extravaganza health requirements will not be granted access to the Indiana State Fairgrounds.
 2. **Before leaving for the show, please double check CVI's to make sure all information is accurate and all requirements are met.** It is best to provide your veterinarian a copy of the show health requirements and check to make sure each item listed is included on your CVI's.
 3. **ALL animals (including deliveries) MUST be officially identified with a federally approved, permanently numbered ear tag. 840 USDA tags are preferred.** For more information on federally approved ear tags, please visit http://www.nationalswine.com/shows/ear_tags.php.
 4. Weanling pigs entered in sift will be provided with an additional sale tag during check-in. **It is preferred that sale tag be placed in the right ear of all purebred weanlings and left ear of all crossbred weanlings.**
 5. Purebred entries must be recorded by Thursday, January 23rd or you will be charged a rush fee (no exceptions).

ARRIVAL, PENNING

1. Please do not arrive before 8 a.m., Thursday, February 6th. **Check-in with the NSR Staff and the Indiana State Board of Animal Health officials before unloading any animals.** Follow the signs for health official's check-in and trailer parking.
 2. **Prior to unloading, state officials will inspect animals and only original health certificates. Please have all animals' ORIGINAL health certificates ready for inspection upon arriving at vet check station. Copies of the approved originals will be accepted by the NSR after approval by state officials. Approved originals can be copied during check-in.**
 3. **Weanling pigs will be penned three head per pen, per exhibitor** (i.e.: if an exhibitor enters four head, they will receive two pens).

CHECK-IN

1. Weanling Exhibitors:

- A. Weanling pigs must be checked-in by Noon on Friday, February 7th.

 - B. Please bring **original health certificate** that has been stamped and approved by health officials to check-in. Copies of original can be made outside the show office if you have multiple animals on the same form.

 - C. Please bring pedigrees of purebred animals to show office during check-in. **Pedigrees must accompany all purebred entries at check-in to participate in purebred classes (NO EXCEPTIONS).**

 - D. **When completing your cards during check-in for the weanling sift, please complete all requested information.** We need your complete address to get your check mailed to you in a timely manner.

 - E. Weanling pig sale order will be based on sift, and at NSR Staff discretion. A sale order will be created for the Female Pig Sale and Male Pig Sale. Both sales will be held Saturday, February 8th, starting at 5 pm. *Tentative

HEALTH REGULATIONS

- 1. **-EACH ANIMAL ENTERING THE INDIANA STATE FAIRGROUNDS MUST BE LISTED ON AN OFFICIAL, INTERSTATE CERTIFICATE OF VETERINARY INSPECTION (CVI) ISSUED BY A LICENSED, ACCREDITED VETERINARIAN. THIS INCLUDES DELIVERY ANIMALS.**
 - A. CVIs must be issued on or after Wednesday, January 8, 2025.
 - B. All animals and original CVIs will be inspected by show veterinarian and show staff prior to unloading.
 - C. Multiple animals may be listed on one original CVI. Photocopies of CVIs can be made during show check-in for each animal after the show veterinarian has approved CVIs upon arrival.

D. A pre-entry movement permit number must be listed on the CVI. Please use **INDY2025**. Individual permit numbers will not be issued by the Indiana State Board of Animal Health for this event.

2. CVIs MUST BE ISSUED ON OR AFTER Wednesday, January 8, 2025 WITH THE FOLLOWING INFORMATION:

A. Each CVI must show: Name and address of consignor, and be consigned to National Swine Extravaganza, Indiana State Fairgrounds, 1202 East 38th St, Indianapolis, IN 46205.

B. ALL animals MUST be officially identified with a federally approved, permanently numbered ear tag. 840 ear tags are preferred. For more information on federally approved ear tags, please visit www.nationalswine.com.

C. In addition to official identification, each animal shall be individually identified by ear notch, which MUST be listed on the CVI.

D. Health status of animal, including dates of required tests and vaccinations must be listed.

E. A premise ID number for the consignor/origin MUST be included on CVI.

F. The pre-entry movement permit number: "**INDY2025**". *Individual permit numbers will not be issued by the Indiana State Board of Animal Health for this event.*

G. The cell phone number of your veterinarian who issued the CVI MUST be included on the CVI.

H. ALL CVIs MUST CARRY THE FOLLOWING STATEMENTS – “Farm or origin of swine:

i. Has not had pseudorabies or swine dysentery in the last 12 months

ii. Has not had any clinical signs or diagnosis of TGE or PEDv in the last 60 days

iii. Feeds no raw garbage and uses no PRV vaccine

iv. Is not under quarantine for any disease condition

v. Has not had vesicular stomatitis diagnosed within 10 miles of farm of origin in the last 30 days

3. REQUIRED TESTS AND VACCINATIONS

A. VACCINATIONS:

1. All WEANLING animals MUST be vaccinated against mycoplasma & circovirus.
 2. The date(s) of vaccination (month, day, year) MUST be listed on CVI.
 3. It is strongly recommended that all animals are vaccinated against influenza.
- ***Some requirements above are in addition to the state of Indiana regulations. However, they are necessary in meeting other state requirements for purchasers of show animals through sales as animals are reconsigned to new destinations.***
