GENERAL INFORMATION

TO: 2026 EXTRAVAGANZA EXHIBITORS

RE: GENERAL INFORMATION, HEALTH REGULATIONS

You are receiving this letter as confirmation of your NSR Extravaganza entries. Please adhere to the following reminders regarding general show information, arrival at the fairgrounds, penning, and health regulations.

EXHIBITOR REQUIREMENTS

- If an exhibitor has an NSR account that is past due, funds from the sale of their animals will be applied to their past-due account.
- If you have entries that will not be exhibited, please inform Lisa Kennedy as soon as possible at lisa@nationalswine.com or (765) 463-3594, ext. 105.

BEFORE LEAVING FOR THE EVENT, PLEASE REMEMBER:

- **ALL animals entering the Indiana State Fairgrounds MUST be listed on an official interstate health certificate of veterinary inspection (CVI) issued by a licensed, accredited veterinarian.** Loads containing swine that do not meet all NSR Extravaganza health requirements will not be granted access to the Indiana State Fairgrounds.
- **Before leaving for the sale, please double-check CVI's to make sure all information is accurate and all requirements are met.** It is best to provide your veterinarian a copy of the sale health requirements and check to make sure each item listed is included on your CVI's. **NOTE:** All health papers must include the ear notch of the pig.
- **ALL animals (including deliveries) MUST be officially identified with a federally approved, permanently numbered ear tag. 840 USDA tags are preferred.** For more information on federally approved ear tags, please visit http://www.nationalswine.com/shows/ear_tags.php.
- Weanling pigs entered in the sift will be provided with an additional sale tag during check-in. **It is preferred that sale tag be placed in the right ear of all purebred weanlings and left ear of all crossbred weanlings.**
- Purebred entries must be recorded by Friday, January 30th or you will be charged a rush fee (no exceptions).

ARRIVAL & DEPARTURE

- Please do not arrive before 8 a.m., Thursday, February 5th, and all weanlings must be in place by 10 a.m. Friday, February 6th. **Check-in with the National Swine Registry officials before unloading any animals.** Follow the signs for health official's check-in and trailer parking.
- **Prior to unloading, state officials will inspect animals and only original health certificates. Please have all animals' ORIGINAL health certificates ready for inspection upon arriving at vet check station. Copies of the approved originals will be accepted by the NSR after approval by state officials. Approved originals can be copied during check-in.**
- **There will be pen cards for all entries. Do Not Move These Pen Cards!**
If your plans have changed and you are not bringing entries, please contact us as soon as possible.
- **Weanling pigs will be penned three head per pen, per exhibitor** (i.e.: if an exhibitor enters four head, they will receive two pens)
- Any animals unloaded prior to veterinarian inspection will be dismissed from barns and forfeit participation in the sift & sale.

ANIMAL REQUIREMENTS

- Recommended farrowing date for Extravaganza pigs is November 1, 2025, and after.
- All purebred weanling pigs shown in purebred classes must have a pedigree which accompanies each entry or they will show as a crossbred. Purebred pedigrees will be transferred to buyers by respective breed associations.
- All pedigrees for purebred entries must be recorded by January 30, 2026, or an additional rush fee will be charged.
- All entries must be ear notched using the official NSR system (starting with number 1 in January and again in July of each year).

- Barrows, boars and gilts are eligible for entry. Barrows and boars may be sifted in the same classes, depending on number of entries. Gilts will be sifted in separate classes.

DNA STRESS STATEMENT

- No known stress positive or stress carrier Duroc, Hampshire, Landrace or Yorkshire animals will be allowed to be exhibited or sold at any NSR-sponsored event.
- Such warranty is, however, solely that of the seller and not that of the American Landrace Association (ALA), American Yorkshire Club (AYC), Hampshire Swine Registry (HSR) or the United Duroc Swine Registry (UDSR).
- The ALA, AYC, HSR and UDSR assume no responsibility or liability in connection with such warranty by the seller.
- If any NSR purebred animal sold at this conference is found to be a carrier of the stress gene, the purchaser has the right to receive full refund of the purchase price from the seller.
- DNA testing for the stress gene must be done within 60 days of the sale date, and all costs associated with testing for stress must be paid by the purchaser. The seller has the right to review the test results and the right to re-test the animal at a laboratory of his/her choice.
- Cost associated with re-test by the seller is at the seller's expense. There will be no refund of NSR commission from stress-carrier animals.

WEANLING SALE INFORMATION

- A minimum of 50% of the pigs in each breed will be selected for the sale.
- All animals selected and cataloged for the sale MUST go through the auction. Sale commission will be 15% for all animals. If an animal that is selected and cataloged for sale does not go through the sale ring, the exhibitor will be banned from exhibiting at NSR events for one year and will be charged 15% of the average selling price of their respective breed sale. This amount must be paid before reinstatement will be allowed. The exception to this rule will be if an animal has become injured or ill and is inspected by a NSR staff member prior to the sale.
- The NSR acts only as the agent between buyer and seller. If proper payment is made by the buyer in a timely manner, the NSR will make settlement with the seller in approximately 30 days after the sale. In the event of non-payment and/or insufficient funds by the buyer, settlement with the seller will be delayed until collection is secured. If an exhibitor has an NSR account that is past due, funds from the sale of their animals will be applied to past-due accounts.

PUREBRED BREED ELIGIBILITY REQUIREMENTS

- By entering any purebred hog in the NSR Extravaganza, the owner warrants that the hog meets specific breed requirements.
- Such warranty, however, is solely that of the seller and not that of the HSR, ALA, AYC and UDSR and the HSR, ALA, AYC and UDSR assumes no responsibility or liability in connection with such warranty by the seller.

- If any Hampshire, Landrace or Yorkshire animal sold at the NSR Extravaganza is found to be a carrier of the color gene after being tested through the procedures approved by the HSR,

ALA and AYC, the seller agrees that he/she will promptly refund the full purchase price to the buyer. There will be no refund of NSR commission from animals that are carriers of the color gene.

Health Regulations

- 1. EACH ANIMAL ENTERING THE INDIANA STATE FAIRGROUNDS MUST BE LISTED ON AN OFFICIAL, INTERSTATE CERTIFICATE OF VETERINARY INSPECTION (CVI) ISSUED BY A LICENSED, ACCREDITED VETERINARIAN. THIS INCLUDES DELIVERY ANIMALS.**

- A. CVIs must be issued on or after Wednesday, January 7, 2026.**

- B. All animals and original CVIs will be inspected by show veterinarian and show staff prior to unloading.
- C. Multiple animals may be listed on one original CVI. Photocopies of CVIs can be made during show check-in for each animal after the show veterinarian has approved CVIs upon arrival.
- D. A pre-entry movement permit number must be listed on the CVI. Please use **INDY2026**. Individual permit numbers will not be issued by the Indiana State Board of Animal Health for this event.

2. CVIs MUST BE ISSUED ON OR AFTER Wednesday, January 7, 2026 WITH THE FOLLOWING INFORMATION:

- A. Each CVI must show: Name and address of consignor, and be consigned to National Swine Extravaganza, Indiana State Fairgrounds, 1202 East 38th St, Indianapolis, IN 46205.
- B. ALL animals MUST be officially identified with a federally approved, permanently numbered ear tag. 840 ear tags are preferred. For more information on federally approved ear tags, please visit www.nationalswine.com.
- C. In addition to official identification, each animal shall be individually identified by ear notch, which MUST be listed on the CVI.
- D. Health status of animal, including dates of required tests and vaccinations must be listed.
- E. A premise ID number for the consignor/origin MUST be included on CVI.
- F. The pre-entry movement permit number: "**INDY2026**". *Individual permit numbers will not be issued by the Indiana State Board of Animal Health for this event.*
- G. The cell phone number of your veterinarian who issued the CVI MUST be included on the CVI.
- H. ALL CVIs MUST CARRY THE FOLLOWING STATEMENTS – “Farm or origin of swine:
 - i. Has not had pseudorabies or swine dysentery in the last 12 months
 - ii. Has not had any clinical signs or diagnosis of TGE or PEDv in the last 60 days
 - iii. Feeds no raw garbage and uses no PRV vaccine
 - iv. Is not under quarantine for any disease condition

- v. Has not had vesicular stomatitis diagnosed within 10 miles of farm or origin in the last 30 days

3. REQUIRED TESTS AND VACCINATIONS

A. VACCINATIONS:

- 1. All WEANLING animals MUST be vaccinated against mycoplasma & circovirus.
- 2. The date(s) of vaccination (month, day, year) MUST be listed on CVI.
- 3. It is strongly recommended that all animals are vaccinated against influenza.

- ***Some requirements above are in addition to the state of Indiana regulations. However, they are necessary in meeting other state requirements for purchasers of show animals through sales as animals are reconsigned to new destinations.***
