RE: GENERAL SHOW INFORMATION, HEALTH REGULATIONS

You are receiving this letter as confirmation of your NSR Fall Classic entries. Please adhere to the following reminders regarding general show information, arrival at the fairgrounds, penning and health regulations.

DUE TO SPACE LIMITATIONS, PLEASE ADHERE TO THE FOLLOWING:

BEFORE LEAVING FOR THE EVENT, PLEASE REMEMBER:

- 1. ALL animals entering the Stephens County Fairgrounds MUST be listed on an official interstate health certificate of veterinary inspection (CVI) issued by a licensed, accredited veterinarian. This includes deliveries and parking lot sales.** Loads containing swine that do not meet all NSR Fall Classic health requirements will not be granted access to the Stephens County Fairgrounds.
- 2. Before leaving for the show, please double check CVI's to make sure all information is accurate and all requirements are met.** It is best to provide your veterinarian a copy of the show health requirements and check to make sure each item listed is included on your CVI's.
- 3. ALL animals (including deliveries and parking lot sales) MUST be officially identified with a federally approved, permanently numbered ear tag. 840 USDA tags are preferred.** For more information on federally approved ear tags, please visit http://www.nationalswine.com/shows/ear_tags.php.
- 4. ATTENTION ALL OKLAHOMA EXHIBITORS- SWINE ORIGINATING FROM OKLAHOMA MUST HAVE AN OFFICIAL ELECTRONIC 840 TAG.**
- 5. Weanling pigs entered in sift will be provided with an additional sale tag during check-in. It is preferred that sale tag be placed in the right ear of all purebred weanlings and left ear of all crossbred weanlings.**
- 6. Please contact Lisa Kennedy (lisa@nationalswine.com or 765.463.3594 ext. 105) with the ear notches and registration numbers of your **NSR breeding show entries** by **Thursday, October 12**. This does not apply to weanling entries.**
- 7. Purebred entries must be recorded by Monday, October 9 or you will be charged a rush fee (no exceptions).**
- 8. Exhibitors of crossbred boars in the breeding show MUST present a documented stress test result** at check-in for crossbred boar entries. This does not apply to weanlings.
- 9. There are NO pets allowed in the barns at the Fall Classic.**
- 10. There is NO smoking in the livestock barns.**
- 11. Snaring of any animals will not be allowed in the barn.**

ARRIVAL, PENNING

1. Please do not arrive before 8 a.m., Wednesday, October 18. Enter through the gate on the west side of the fairgrounds. **Check-in with the Oklahoma Department of Agriculture-Animal Industries officials before unloading any animals.** Follow the signs for health official's check-in and trailer parking.
2. **Prior to unloading, state officials will inspect animals and only *original* health certificates.** *Please have all animals' ORIGINAL health certificates ready for inspection upon arriving at vet check station.* Copies of the approved originals will be accepted by the NSR after approval by state officials. Approved originals can be copied during check-in.
3. **All trailers must park in the designated areas!** The Stephens County Fair staff will coordinate the Claud Gill Arena to provide trailer parking and housing of all swine that are not entered in the Fall Classic shows and sales. *A per vehicle fee will be charged for all vehicles with swine that are housed at the Claud Gill Arena.* The fee will go to the Stephens County Fairgrounds for maintenance and to provide veterinary service to reassign/reissue CVIs to buyers of parking lot pigs. *Trailers that are not parked in designated areas will be towed.* No trailers are allowed in the barn parking lots.
4. **There will be pen cards for all entries in the breeding & weanling barns. Do Not Move These Pen Cards!** *If your plans have changed and you are not bringing entries, please contact us as soon as possible. No tack pens will be allowed at the Fall Classic.*
5. **Weanling pigs will be penned three head per pen, per exhibitor** (i.e.: if an exhibitor enters four head, they will receive two pens).
6. Breeding animal pen dimension for NSR open show hogs are 6' x 6'. Weanling pen dimensions vary due to a variety of pen types in the upper and middle barn. Weanling pen sizes range from 4' x 6' to 5' x 5'.

CHECK-IN

1. **Weanling Exhibitors:**
 - A. Weanling pigs must be checked-in by 9 a.m. on Thursday, October 19 in the upper barn show office.
 - B. Please bring **original health certificate** that has been stamped and approved by health officials to check-in. Copies of original can be made outside the show office if you have multiple animals on the same form.
 - C. Please bring pedigrees of purebred animals to show office during check-in. **Pedigrees must accompany all purebred entries at check-in to participate in purebred classes (NO EXCEPTIONS).**
 - D. **When completing your cards during check-in for the weanling sift, please complete all requested information.** We need your complete address to get your check mailed to you in a timely manner.
 - E. Weanling pig sale order will be based on sift placings. A sale order will be created for the Female Pig Sale and Male Pig Sale. Both sales will be held Saturday morning, October 21, starting at 9 am.
2. **NSR Breeding Animal Exhibitors:**
 - A. Please bring the **original health certificate** that has been stamped and approved by health officials to check-in. Copies of the original can be made outside the show office if you have multiple animals on the same form.
 - B. **Crossbred boars being exhibited in the breeding animal show are required to be DNA stress tested. Please bring your documented test results with you to present during check-in.** We will place their

stress status in the show and sale catalog. To expedite the check-in process, please fill out the Crossbred Breeding Information form here:

- C. Exhibitors of crossbred boars in the breeding show will be provided pen cards at check-in.
 - D. All Crossbred Boars will be weighed at 9 a.m. on Thursday, October 19 in the south arena showing. **Be sure to have your animal's lot number that has been assigned with you when weighing.**

2023 Fall Classic Health Regulations

1. EACH ANIMAL ENTERING THE STEPHENS COUNTY FAIRGROUNDS MUST BE LISTED ON AN OFFICIAL INTERSTATE CERTIFICATE OF VETERINARY INSPECTION (CVI) ISSUED BY A LICENSED, ACCREDITED VETERINARIAN. **THIS INCLUDES DELIVERIES AND PARKING LOT PURCHASES. LOADS CONTAINING ANY SWINE WITHOUT ALL THE BELOW MENTIONED REQUIREMENTS WILL NOT BE GRANTED ACCESS TO THE STEPHENS COUNTY FAIRGROUNDS.**
 - A. All animals and CVI's will be inspected by state officials prior to unloading.
 - B. Multiple individual animals may be listed on the same original CVI. **However, breeding stock and weanling pigs must be on separate original CVI's.**
 - C. **All entries coming from outside of Oklahoma** MUST obtain an interstate permit number. Only your accredited veterinarian may obtain this permit number by calling the Oklahoma Department of Agriculture at 405.522.6141 or visit <https://ag.ok.gov/divisions/animal-industry-state-veterinarian> and click on "Animal Movement and Importation". **ELECTRONIC CVIs DO NOT REQUIRE A PERMIT NUMBER.**
 - D. CVI's are not required to be stamped by the state of origin.
2. CVI's **MUST BE ISSUED ON OR AFTER Thursday, September 21, 2023** WITH THE FOLLOWING INFORMATION:
 - A. Name and address of consignor; consigned to Fall Classic, Stephens County Expo and Fair, 2002 South 13th Street, Duncan, OK 73533. Premise ID for the fairgrounds is 00CKK0F
 - B. **ALL animals (including deliveries and parking lot purchases) MUST be officially identified with a federally approved, permanently numbered ear tag.** For more information on federally approved ear tags, please visit http://www.nationalswine.com/shows/ear_tags.php. ***SWINE ORIGINATING FROM OKLAHOMA MUST HAVE AN OFFICIAL ELECTRONIC 840 TAG***
 - C. Ear notches and official identification of each animal MUST be listed on the CVI.
 - D. Health status of animal, including dates of required tests and vaccinations MUST be listed.
 - E. A premises ID number MUST be included on the CVI.
 - F. Your veterinarian's cell phone number MUST be included on the CVI.
 - G. ALL CVIs MUST CARRY THE FOLLOWING STATEMENTS – "Farm or origin of swine":
 1. Has not had Pseudorabies or swine dysentery in the last 12 months
 2. Has not had any clinical signs or diagnosis of TGE or PEDv in the last 60 days

3. Feeds no raw garbage and uses no PRV vaccine
4. Is not under quarantine for any disease condition
5. Has not had vesicular stomatitis diagnosed within 10 miles of farm or origin in the last 30 days

3. REQUIRED TESTS:

A. PSEUDORABIES (PRV) TESTING:

1. ALL ANIMALS MUST be individually tested for PRV **ON OR AFTER THURSDAY, September 21, 2023** UNLESS animals come from a PRV-qualified herd.
 - i. Swine tested must have all official identification and also include sex, ear tag and ear notch along with date blood sample was drawn (month, day and year) and negative results listed on CVI.
 - ii. Animals must test PRV-negative with all results on the dated CVI.
 - iii. Either the ELISA (gB ELISA), ALA or S/N tests are acceptable. Differentiable ELISA (g1 ELISA) test will NOT be accepted.
 - iv. If the herd of origin is PRV qualified, individual testing of each animal is not required. In this case, the PRV qualification number must appear on the CVI and the most recent quarterly herd test date (month, day and year) must be stated on the CVI. **The earliest quarterly test date that will be accepted will be July 24, 2023.**

B. BRUCELLOSIS TESTING:

1. ALL ANIMALS MUST be individually tested for brucellosis **ON OR AFTER THURSDAY, September 21, 2023** UNLESS animals originate from a validated brucellosis free herd.
 - i. Swine tested must have all official identification and also include sex, ear tag and ear notch along with date blood sample was drawn (month, day and year) and negative results listed on CVI.
 - ii. Animals must test brucellosis negative with all results on the dated CVI.
 - iii. The RAP, Standard Plate, Standard Tube or BAPA brucellosis tests are all accepted.
 - v. If the herd of origin is brucellosis validated, individual testing of each animal is not required. In this case, the validation numbers must appear on the CVI and the most recent quarterly herd test date (month, day and year) must be stated on the CVI. **The earliest quarterly test date that will be accepted will be July 24, 2023.**

4. VACCINATIONS:

- A. ALL animals being exhibited in the breeding shows MUST be vaccinated against Leptospirosis (6-way) including Bratislava and Erysipelas **ON OR AFTER September 21, 2023**. The complete date of vaccination MUST be listed on the CVI. **This is not a requirement for weanling pigs.**
- B. All WEANLING animals MUST be vaccinated against mycoplasma & circovirus. **This is a sale requirement for weanling pigs only.**
- C. It is strongly recommended that all animals are vaccinated against influenza. This is not a requirement.

5. PERMIT REQUIREMENT

- A. All entries coming from outside of Oklahoma MUST obtain an interstate permit number. Only your accredited veterinarian may obtain this permit number by calling the Oklahoma Department of Agriculture at 405.522.6141 or visit <https://ag.ok.gov/divisions/animal-industry-state-veterinarian> and click on "Animal Movement and Importation". **ELECTRONIC CVIs DO NOT REQUIRE**

NSR Fall Classic

Outdoor Arena/Rodeo Grounds Trailer Parking & Weanling Pig Sales

Heightened biosecurity concerns nationwide have been the topic of discussion in several recent swine industry leadership meetings. One specific event that has continually entered the discussion has been the outdoor arena pig sale at Duncan. Biosecurity concerns stemming from the 2021 Fall Classic outdoor arena pig sales prompted a discussion within the NSR Executive Committee to revamp the policy and procedures for selling weanling pigs off the trailer at the Fall Classic. ALL pigs coming onto the grounds must meet the Fall Classic health regulations – Oklahoma Department of Agriculture veterinarians check each pig and Certificate of Veterinary Inspection (CVI) upon arrival for admittance to the grounds. However, in the past pigs have been leaving the Stephens County fairgrounds without proper health certificates. Interstate transport of livestock without proper health certificates not only compromises the integrity of our show industry and puts the commercial swine industry at risk, but it is also illegal. Several buyers found this out the hard way when trying to return to Texas with weanling pig purchases in 2021.

To strengthen the biosecurity of the NSR Fall Classic, veterinary service will be available on the grounds, so outdoor arena trailer sellers can re-consign their pigs to the buyers, and the buyers can leave the grounds with a valid CVI. This service will be provided at no additional veterinarian cost to buyers. In 2022, approximately 90% of weanlings merchandized through the Outdoor Arena/Rodeo Grounds were reconsigned and issued new health papers.

To provide this service, the cost to enter the Outdoor Arena/Rodeo Grounds Parking Lot to merchandize weanling pigs will be \$250 per trailer. If you have made at least five (5) entries for the Fall Classic Weanling Pig Sift or made at least three (3) entries in the Breeding Stock Show, you will receive entry for \$50 per trailer. If you don't intend to sell weanling pigs in the Outdoor Arena/Rodeo Grounds, you will be eligible to park your trailer at no cost like previous years.

IMPORTANT REMINDERS

- **We highly recommend printing these requirements and reviewing them with your veterinarian.**
 - **Please review CVI's prior to leaving for the event to ensure all required information is completed accurately.**
 - **Oklahoma Exhibitors: Some requirements listed above may be in addition to the health requirements for fall shows in Oklahoma. However, they must be included on the animals CVI's in order to be exhibited at the Fall Classic**
 - Oklahoma Department of Agriculture Veterinarians will inspect all animals and CVI's prior to unloading. Any animals not meeting health requirements may be prevented from exhibition at this event.
 - In some instances, these rules are in addition to Oklahoma regulations, but are necessary to sell animals into other states to meet interstate transport and entry requirements for swine.
 - The rules above are the same for breeding stock & weanling pigs unless specified otherwise.
